Sir,

Since our last Community Meeting regarding quality of life issues, there has been significant progress in the curtailing of such activity. The Patrol Division has stepped up its efforts in controlling and containing these disturbances.

Although a cursory CAD inspection will show that there have been several locations with three or more visits from the police, a more detailed inspection will show that the majority of these calls for service have been handled with the use of discretionary police powers. (Advising, shutting down, etc)
