On-Hours Incidents Reviewed

- There were 29 requests for a review of camera footage from the on-hours (10pm 6am)
- The footage was reviewed and recordings were made in 13 requests.
 - Footage was provided to:
 - Traffic Officers (1)
 - Evidence (11)
 - MBTA Investigator (1)
 - Recordings were not made in five requests due to:
 - Nothing of value being visible on the footage (6)
 - Camera out of view (4)
 - Camera being out of service (4)
 - No investigation (2)

On-Hours Incidents Reviewed (cont)

- Types of incidents that the footage was reviewed/requested for:
 - Assault/Assault & Battery (6)
 - Motor Vehicle Crash (6)
 - OUIL (5)
 - Robbery (3)
 - Larceny (2)
 - MV Pursuit (2)
 - Bomb Threat
 - Car Breaks
 - Graffiti
 - Home Invasion
 - Internal Affairs Investigation



System Overrides

- During 2012, there were 33 overrides of the camera system (turning the camera on during the off-hours of 6am-10pm).
- Overrides were initiated by:
 - Dispatchers (10)
 - BPD IT Director (23)


